- Xtreme Landscaping found various leaks in the sprinkler system, including the main water line. They are in the process of acquiring necessary material to fix and locate more leaks.
- Randy left a lengthy message to Mr. Becksted (lawyer) regarding 20A. We are waiting for a response.
- Four Seasons replaced damaged and missing tiles on Saturday,
   December 8. The problem relates back to the builders who used short screws to affix the tiles. Four Seasons replaced with long screws.
